James D. Nicholson Advisor The Quebec Branch is always on the lookout for topics of interest to its members, especially when it comes to the protection of seniors. This is the case with the signing of a national framework agreement to combat elder abuse, a concrete step announced last month by the Minister Responsible for Seniors and the Fight Against Bullying. This agreement allows for better consultation among key government stakeholders. It offers concrete means to fight against abuses of all types. With the Minister Responsible for Seniors and the Fight Against Bullying, seven other departments and government organizations signed this agreement, namely, the Ministries of Health and Social Services, Public Safety and Justice, Criminal and Penal Prosecution Services, the Autorité des marchés financiers, the Curateur public and the Commission des droits de la personne. This new partnership promotes effective dialogue between all stakeholders in the community, with the goal of ensuring a better intervention, to put an end to situations of elder abuse. Related to the protection of seniors is the guide «Vos finances en toute sécurité: Guide à l'intention des aînés» (in French). This guide was written to better inform seniors so as to protect them from financial abuse. This guide was published by Option Consommateurs in cooperation with the Antoine-Turmel Research Chair of the Faculty of Law of Laval University on the legal protection of seniors.

Aline Grenier Ruelland, a member of our section, has just celebrated her 100th birthday. The Quebec Branch is very proud of her! We met her in her family home in Quebec City. Mrs. Ruelland began her career in the federal government in 1946 in Quebec City. Already at work during the Second World War, she changed jobs at the age of 28, to become a bilingual typist with the Department of National Revenue. Quebec was a major Canadian Income Tax Centre at the time. She made use of her knowledge acquired at the Thomas Institute on Saint-Stanislas Street in Quebec City, a private college offering office training, including typing. It served her well throughout her career.

Mrs. Ruelland was at ease in English, which language she learned with a first love. Her duties were varied within the department. "There needed to be an effective filing system to receive and process the many tax returns of Canadians, and errors were not allowed ...".

Mrs. Ruelland has worked with several generations of photocopiers and saw the arrival of the electric typewriter, "an important change," she says! Over time, she became a good friend of many colleagues, one of whom told me how Mrs. Aline was energetic, always ready to help and contributed to the warm atmosphere of her workplace.

Mrs. Ruelland got married and continued her work in the same Income tax Department, now the Revenue Canada Agency. She retired in 1983.

Our century-old colleague has reserve of anecdotes, recounted with her phenomenal memory and keen eye! Autonomous, she accepts with pleasure the support of nephews and nieces who keep an eye on her comfort and needs. They are all happy to celebrate their aunt's 100th birthday.

A RESEARCH CHAIR ON LEGAL PROTECTION OF THE ELDERLY AT LAVAL UNIVERSITY'S FACULTY OF LAW

Established in September 2014, thanks to two major donations from the Antoine-Turmel Foundation, the Antoine-Turmel Research Chair on legal protection of the elderly is the first Quebec Chair whose main focus is the protection of elders from a legal perspective. It brings together professors, researchers and students from different disciplines.

The mission of the Chair is to promote and support research, training and dissemination of knowledge about elder law in a perspective of protection and respect for the autonomy of the elderly. Its main objective is to study the legal protection mechanisms of older adults and their implementation in order to disseminate information and identify areas for improvement, where appropriate.

Why such a Chair? At a time when demographics show the aging of the population, there is reason to be concerned about the special situation of elders, particularly with respect to their rights. There are various reasons for paying special attention to the rights of elderly people. These include the fact that with old age, more people are prone to a decrease in their abilities, whether due to aging or illness. Some elderly people may find themselves in a vulnerable situation, be it physically, psychologically, socially or economically. It should also be noted that some elderly people are aging alone, without the help of their family members. On the contrary, others are surrounded by several relatives, whose conflicting interests may be in opposition: we can think of the spouse, former spouses and children born of different unions. They can then find themselves at the centre of family tensions.

Finally, we have to keep in mind situations where some elderly people own property of considerable value which they are likely to transmit in the short or medium term.

The part of the Law being developed by the Chair could be considered «a work in progress» in Quebec, being better known in the rest of Canada and the United States under the name of «Elder Law».
